Notice of Public Information Meeting

Tehama County/Red Bluff Landfill and Materials Recovery Facility, Revised Solid Waste Facilities Permits

PUBLIC NOTICE IS HEREBY GIVEN in compliance with Title 27 of the California Code of Regulations (27 CCR), Section 21660.3 that the Tehama County Department of Environmental Health, Local Enforcement Agency (LEA), received application packages for revised Solid Waste Facilities Permits to allow the construction of a Tier 2 Composting Facility at the Tehama County/Red Bluff Landfill (SWIS# 52-AA-0001) and increase the combined maximum daily traffic volume for the Landfill and the Tehama County/Red Bluff Materials Recovery Facility (SWIS# 52-AA-0027) from 400 to 600 vehicles per day. The LEA's Preliminary determination is that the proposed changes are considered significant changes and each requires a revised SWFP, pursuant to 27 CCR Section 21665. The application packages were accepted as complete and correct per 27 CCR Section 21650 on March 21, 2025.

Purpose of the Meeting:

The LEA is required to conduct a public informational meeting pursuant to 27 CCR Section 21660.2 to provide information to the public and receive comments on the LEA's proposed action to revise a SWFP. This informational meeting is to inform the public about the proposed revisions to the SWFP for the proposed update to allow the construction and operation of a Tier 2 Composting Facility and increase the maximum daily traffic volume at the Tehama County/Red Bluff Landfill and Materials Recovery Facility, and to allow the public to provide comments to the LEA regarding the proposed permit action. After the meeting, the proposed revised Solid Waste Facilities Permits along with the application package and comments from this meeting will be submitted to the California Department of Resources Recycling and Recovery (CalRecycle) for their concurrence. The decision to issue or not to issue the revised permits must be made by the LEA within 120 days of the date the application was deemed complete and correct and after concurrence from CalRecycle.
