In existing dwelling units, alarms are permitted to be solely battery operated where repairs or alterations do not result in the removal of wall and ceiling finishes OR there is no access by means of attic, basement or crawl space. See Sections R314, 907.2.11.4 and 420.4.1.1 of the California Building and California Residential Codes. An electrical permit is required for alarms which must be connected to the building wiring.
