

## **Park Fire**

The Park Fire ignited on July 24, 2024, in Chico California's iconic Bidwell Park. The fire quickly spread from Butte County into Tehama County posing serious threats to neighboring Plumas and Shasta Counties before ultimately burning 429,603 acres – most of which were within Tehama County.

The Tehama County Department of Agriculture is grateful for the collaboration with CAL FIRE, whose swift and professional coordination with Office of Emergency Services, and the U.S. Forest Service helped ensure public safety and preservation of the agriculture industry.

The Department is appreciative and proud of the efforts of our local entities, including the Tehama County Sheriff's Office, Tehama County Environmental Health, Tehama County Fire Department, Tehama County Administrative Office, Tehama County Department of Public Works, Tehama County Board of Supervisors, Tehama County Division of Animal Services, Tehama County Cattlemens Association, volunteer organizations, and the citizens of Tehama County. Their dedication and teamwork towards helping our community were vital during this crisis.

The Department is grateful for the coordination and implementation of the AG Pass program, which, through cooperation from the California Highway Patrol, allowed agricultural producers with an AG Pass to access restricted areas of the Park Fire to care for and preserve their livestock. Special thanks also go to the U.C. Davis Cooperative Extension Office and the Shasta County Department of Agriculture who throughout the event provided agricultural producers with the required training to obtain their Ag Passes.

The Tehama County Department of Agriculture is proud to be a part of a community so eager and willing to assist those in need, and thankful to all those who offered support.

It is my pleasure to present the 2024 Tehama County Crop and Livestock Report that is prepared pursuant to the provisions of Section 2279 of the California Food and Agricultural Code. This annual report is a summary estimate of acreage, yields, and production values for the agricultural industry in Tehama County. All figures in the report represent gross values only and do not reflect net income of producers.

The total gross value of Tehama County agricultural production in 2024 was \$407,789,400. This represents an increase of 34% (\$104,423,400) from the value in 2023.

Almonds surpassed walnuts as Tehama County's top crop with an overall value of \$115,974,600. Fruit and nut crops continued to be the top producing category, with a total value of \$281,591,600, which represents an overall increase of 52% from 2023.

Almonds more than doubled in value (129%) due to increase in yield and price per ton. Other crops that increased in value include: walnuts (75%), pistachios (2%), apiary products and services (8%) and vegetable crops (128%). Table olives dropped in value (-15%) but still held on to the number 5 spot for the top five commodity produced in Tehama.

Beef Cattle total value for 2024 increased by (18%), moving it up from the number 4 spot to the number 3 spot in the top five commodities for Tehama County. Field crops increased in value by (7%) due to an increase in values across the board and seed crop value decreased for the second consecutive year falling another (69%) due to another significant drop in the number of acres planted.

The top five highest value agricultural commodities for Tehama County in 2024 were:

#1 - Almonds - \$115,974,600

#2 – Walnuts - \$95,373,600

#3 – Beef - \$34,912,600

#4 - Apiary - \$28,043,500

#5 - Table Olives - \$25,624,400

My sincere appreciation is extended to the growers, processors, government agencies, and others that provided information used in preparing this report. This publication would not be possible without their combined efforts. I wish to thank my staff that assisted in compiling this report with special recognition to Agricultural Biologist Kim Smith for the report's overall coordination and production.



## Sustainable Agricultural Report

In accordance with Section 2272 of the California Food and Agriculture Code, the Sustainable Agricultural Report provides a brief account of efforts being made to exclude or eradicate exotic pests and to best manage those which already exist in a manner most conducive to the protection of agricultural production and our environment.

#### Quarantine Inspections – 1<sup>st</sup> Line of Defense

During 2024, 268 shipments of agricultural products were inspected for compliance with quarantine requirements, which resulted in no live detections. These included 45 border station hold notices (008). 182 glassy-winged sharpshooter interior hold notices (blue tags), and 41 truckloads of bee hives.

#### Pest Prevention - 2<sup>nd</sup> Line of Defense

Tehama County's pest prevention program included pest detection trapping for several exotic pests. Trapping and nursery inspections were conducted for brown apple moth and glassy-winged sharpshooter. European grapevine moth traps were placed in commercial grape vineyards. Asian citrus psyllid traps were deployed throughout the county during a winter trapping survey.

Tehama County encompasses approximately 1,904,640 acres, which are surveyed by our department for noxious weeds listed by California Department of Food and Agriculture. In 2024, five noxious weeds were under eradication and five species were under limited control treatment.

## Organic Farming and Direct Marketing

#### **Organic Farming**

In 2024, Tehama County had 29 registered organic growers. Organically farmed land totaled 13,633 acres, including rangeland. Operations range from small gardens catering to local Certified Farmer's Markets to livestock, dairy, orchard, and field crop producers providing products on a larger scale





#### **Certified Farmer's Markets (Direct Marketing)**

Certified Farmer's Markets are diverse marketplaces that allow farmers to sell directly to the consumer and allows the consumer to directly interact with the farmer to learn how their food is produced. Tehama County issued 30 Certified Producer Certificates in 2024.
